NASSAU CHAPTER HIGH SCHOOL SCHOLARSHIP

PURPOSE: To provide Financial Assistance to dependent children and grandchildren of members in good standing of the Nassau Chapter for the furthering of their Catholic High School education.

SCHOLARSHIP: Scholarships are awarded based upon the scholastic aptitude of the child and the child's activities within their Church and community. The scholarship is awarded without consideration of financial need. The scholarship is awarded to incoming freshman and may be renewed yearly provided the recipient's scholarship, attendance, behavior and community service is <u>far above standard</u>. Scholarships will be awarded as follows: One renewable scholarship of \$1000.00 payable directly to the school in two payments (usually in September and January). Two one time scholarships of \$500.00 will be awarded to the second and third place students.

REQUIREMENTS:

- I. Applicant must be a child, grandchild, or legal ward of a Knight of Columbus or Columbiette, whose council is a member of the Nassau Chapter in good standing. A Squire or Squirette, whose organizations are sponsored by a council in good standing in the Nassau Chapter, may also apply. Children of deceased members whose demise occurred while in good standing are also eligible.
- 2. Acceptance in a Catholic High School for the year beginning September 2009. Proof of registration will be required.
- 3. Financial Secretary must verify the good standing of member.
- 4. Signature of Parent is required to certify the accuracy of all answers on the application.

FILING OF SCHOLARSHIPS: Financial need is not a factor. The filing of a scholarship application MUST be accompanied with **four (4) documents**:

- 1. A letter of recommendation from an educator of the school currently attended by the applicant. The recommendation should specify the student's scholastic achievements and activities in the school.
- 2. Proof of registration in a Catholic High School for the academic year beginning September 2009.
- 3. **Transcripts** of the students final marks for grades 6 and 7 and the mid-year grades for grade 8(at least 2 semesters or trimesters).
- 4. A composition written by the student describing his or her understanding of the Knights of Columbus and his or her activities within the student's Church and community. *Word processors or computers may be used for this purpose.*

NOTE: DOCUMENTS SUPPLIED OTHER THAN THOSE SPECIFIED ABOVE WILL **<u>NOT</u> BE** CONSIDERED.

All completed applications should be sent to the High School Scholarship Chairman. Applications are available from the Grand Knights and the Scholarship Chairman.

- 6) There will be plaques for First , Second, and Third Place. We'll also give certificates to every council which participates.
- 7) As recommended by the committee, we'll grade newsletters on a 100 point system.

Legislation Unfairly Targets Church

The New York State Legislature is considering a bill that would allow individuals to file civil lawsuits claiming abuse at any time in the past. The bill does not apply evenly to all victims and all institutions. It is selectively targeted at the Catholic Church and other private organizations. Significantly, it would not apply to public schools or other public entities. The proposal would rescind the statute of limitations on abuse-related lawsuits against private organizations for one year, rejecting a legal doctrine respected by generations of judges and legislatures that civil claims should be brought in a timely fashion to ensure a fair and just resolution based on the facts. The New York State Catholic Conference and other religious organizations have urged the Legislature to adopt alternative legislation that treats all victims and institutions fairly and evenly. The unfair legislation, if enacted, could imperil all of the Church's missions and ministries in New York State. Protecting Children from Sexual Abuse in New York State: Two Competing Visions, One Clear Answer.

Two competing visions have emerged in the state Legislature to deal with the difficult issue of sexual abuse victims and their legal rights. One approach -- advanced by Assemblywoman Marge Markey and Sen. Tom Duane -- focuses principally on the past. The other approach -- advanced by Assemblyman Vito Lopez and Sen. Carl Kruger -- focuses entirely on the future.

The bill (A2596 and S2568) sponsored by Assemblywoman Margaret Markey, D-Queens, and Sen. Tom Duane, D-Manhattan:

Principally looks back, not ahead.

- Promotes litigation it resuscitates claims 50, 60, 70 years old, lawsuits now deemed to old to be brought to court, lawsuits that it would be virtually impossible for any organization to defend.
- Does nothing to protect children now.
- Arguably helps some, but nowhere near all, victims of sexual abuse -- and, in fact, discriminates against victims based on the meaningless distinction of where their alleged abuser was employed.
- Overturns a fundamental principle of American law the statute of limitations that was created to prevent fraud and encourage timely and fair resolution of claims. Reviving criminal claims that are beyond the statute of limitations is prohibited by the Constitution of the United States. The same protection is appropriate for civil claims. Selectively targets private institutions, most notably the Catholic Church.
- Exempts public institutions, notably New York's public schools, where far greater numbers of sexual abuse claims have been reported.
- Runs the risk of inflicting catastrophic harm to the Catholic Church in New York, the largest non-government provider of health care, education and human services -- schools, soup kitchens, homeless shelters, health clinics -- in the state, at a time when government funding for these services is being sharply reduced.

Is supported by the powerful New York trial lawyers' lobby.

Is opposed by the New York State Catholic Conference, New York Civil Liberties Union, Legal Aid, the New York State Association of Criminal Defense Lawyers and the Brooklyn Defenders.

The bill (A5708 and S3107) sponsored by Assemblyman Vito Lopez, D-Queens, and Sen. Carl Kruger, D-Brooklyn:

Looks forward and protects children now.

Focuses on prevention.

Treats all victims equally – does not create two, unequal classes of victims.

Does not disenfranchise those abused in public schools, hospitals or agencies

Does not selectively target any institution and places no special burdens on any organizations, religious or otherwise.

Does not overturn a fundamental legal principle (statute of limitations) that is respected by legislatures and courts across the country.

Is supported by the New York Catholic Conference.

Surely, with respect to creating new law, legislators' best efforts should be directed toward **ensuring equal treatment and protection under the law**. It is clear, then, that the better choice is the Lopez-Kruger measure: It protects children now and in the future, extends rather than waiving the civil and criminal statutes of limitation; applies evenly to all institutions, including schools, hospitals and other public institutions as well as churches, nonprofits and businesses; and is fair to the alleged victims and potential plaintiffs, balancing the issues of justice with the goals of the justice system.

With proposed revisions CHARITY * UNITY * FRATERNITY * PATRIOTISM BY-LAWS GOVERNING THE NASSAU COUNTY CHAPTER KNIGHTS OF COLUMBUS "CHAPTER OF THE NEW MILLENIUM"

ARTICLE I - NAME

Section #1

This organization shall be known as the Nassau County Chapter, Knights of Columbus hereinafter referred to as the "Chapter".

ARTICLE II – OBJECTIVES

Section #2

To promote the well being of the Order within Nassau County and among its member Councils. To conduct one major Chapter wide activity per year.

To disburse one-year revenues fund to charitable, educational or religious causes.

To server as a medium of exchange of ideas to benefit our order amongst the Nassau County Councils.

To exemplify Charity, Unity, Fraternity, and Patriotism.

To provide assistance to eligible members in need of help financially and spiritually.

To promote Catholic advocacy and Catholic education.

- To foster and promote recommended programs to insure the moral strength of our youth communities and our church.
- To facilitate and teach our Grand Knights and local leadership in doing the best they can as local Council officers.

To support the New York State and Supreme Council in their deliberations and objectives.

ARTICLE III – MEMBERSHIP

Section #1

The membership of the Chapter with a right to vote shall consist of the following:

The State Deputy of the State of New York

District Deputies having jurisdiction of subordinate councils, affiliated with this Chapter.

Three Delegates: the Grand Knight and two other elected representatives from each Council within Nassau County.

Elected chapter officers Past presidents of the Nassau chapter

Section #2 - Credentials

- The Secretary of the Chapter shall prepare and finish credential blanks to council Financial Secretaries on or before June 1st each year.
- The Financial Secretary of each Council shall prepare and certify a list of the three Delegates from said council and shall forward such list on the regular form provided by the Secretary of the Chapter on or before July 1st of each year.
- Appointments of Delegates, by Grand Knight to fill vacancies or absences, will have the same authority as their elected representative at the particular Chapter meeting for which they were appointed to attend.

No member shall have more than one vote.

ARTICLE IV – ASSESSMENTS

Section #1

Each council within the Boundaries of Nassau County who elect to join said Chapter shall be assessed (\$50.00) fifty dollars per Columbian year (July 1st – June 30th) *or an amount presented and published by the chapter officers and approved by two –thirds of the delegates present at the chapter meeting following the publication.* Dues shall be payable the first quarter of the Columbian year.

Section #2

Councils failing to pay such assessments within the prescribed time shall be denied representation in the Chapter while said default exists. Delegates' credentials, participation in Chapter elections, and anointed or elected office will all be withheld under said rules if assessments are not paid.

ARTICLE V – OFFICERS

Section #1

The officers of the Chapter shall consist of a president, vice-president, secretary, and treasurer, who shall each serve a one year term. The Chapter President may also appoint a Secretary and Warden to his personal staff. The Chapter President on an ad hoc basis may appoint other designees.

Section #2

In order to hold a Chapter office you must be a Third Degree member in good standing and need not be a delegate from your Council. *Elected Nassau Conference officers are ineligible to seek or acquire office as an elected Nassau Chapter officer.*

Section #4 – Duties

- The President of the Chapter shall be the Chief Executive Officer of the Chapter, and shall preside at all Chapter meetings.
- The Vice-President of the Chapter shall perform the duties of the president when the president is absent and shall perform such other duties as may be delegated to him by the president.
- The Secretary shall keep a record of all minutes of the meetings of the Chapter and shall perform such duties as the Chapter may delegate to him.
- The Treasurer shall be the Chief Financial Officer of the Chapter and keep all books and records of financial accounts, signing checks on orders drawn upon him by the Secretary, said checks to be co-signed by the Chapter President. The Treasurer will perform such duties as may be delegated upon him by the Chapter. The Secretary's vouchers and Treasurer's Books and records shall be subject to audit by

an ad hoc auditing committee, appointed by the Chapter meeting following said audit.

Report of activities and finances. The Chapter shall file an annual report of their activities and finances for the preceding fraternal year, with copies to the Supreme Secretary, State Deputy, and the State Secretary. Said report shall be filed no later than August 1st of each year, and shall be signed by the Chapter President, Secretary, and Treasurer.

ARTICLE VI – ELECTIONS

- All Officers shall be elected by ballot at a regular business meeting of the Chapter held on the third Friday in June each year by the elected representatives/delegates and said officers shall hold their offices until the first of July of the following year and until their successors are elected and qualified.
- The laws governing subordinate councils and their officers in the absence of a specific provision to the contrary are applicable to Chapters.
- All elections shall be conducted in accordance with section 93 and other pertinent sections of the Supreme By-Laws.

ARTICLE VII – COMMITTIES

Section #1

The Chapter President shall appoint committees on an ad hoc (as needed) basis. Committee composition shall be for the welfare of our Chapter members and councils, for charitable, educational and religious purposes.

Section #2 At the discretion of the Chapter President the Chapter may activate the following standing committees.

Fraternal Assistance Catholic Fraternal

At the discretion of the Chapter President, the following ad hoc committees may be activated at any given time in the Columbian year.

Nominations/elections Advisory (officers/designees) Fund Raising Memorial Mass Vocations Community Outreach Legislation Youth Athletics Council Outreach Training of Officers Health awareness Installation

All Chairmen shall be appointed by the Chapter President Section #4

Where practical and possible all Chapter committee chairmen shall coincide with the standing committees of the New York Council K of C.

Rules and regulations shall be set forth and implemented to coincide with standing and ad hoc committees.

The Chapter shall conduct one-major Chapter wide activity each year.

ARTICLE VIII – FUNDS

Section #1

The Chapter General Fund shall consist of the following:

Council dues paid Donations of any kind to the chapter Other miscellaneous revenues received

Section #2

No money in excess of *\$500.00* shall be paid or transferred from the treasury of this Chapter (except such monies as the Chapter is called upon to regularly pay for current expenses as provided by cause of the Order or for purposes approved by the Supreme Council or Board of Directors or as specifically set forth in the budget and by-laws of this Chapter as approved expenses). Unless by a two-thirds vote of members present and voting at a regular business meeting held in subsequent to a regular meeting at which notice in writing or intention to pay or transfer such money and the purpose and amount to be paid or transferred shall have been given and regularly read.

Section #3

An operating budget shall be formed each fraternal year by the Chapter officers and an ad hoc Advisory Committee and presented for approval by the Delegates no later than September 30th of each year. The Budget shall be printed in its entirety and voted on after received.

Section #4

All funds shall be in the name of "The Nassau County Chapter, Knights of Columbus."

ARTICLE IX – MEETINGS

Section #1

Regular meetings shall be held on the third Friday of each month at places designated by the Chapter President.

Section #2 Notice of Chapter meetings must be given at least 15 days in advance to Chapter members.

Section #3

Business of the Chapter shall only be conducted by a majority of qualified members to the Chapter.

Section #4

All meetings of the Chapter shall be held in the third section.

Section #5

Twenty-five (25) members representing at least ten (10) different Councils in good standing shall suffice a quorum present.

Section #6

Any 3rd Degree brother of a council in Nassau County may attend meetings of this Chapter but shall not be entitled to a vote except where otherwise provided herein.

Section #7

Designees from other Chapters to our Chapter may attend meetings of this Chapter, with a voice but no vote.

Section #9

Special meetings of the Chapter shall be at the call of the Chapter President, a majority of the officers or on petition of five (5) Grand Knights within Nassau County, directed to the Chapter President who shall upon receipt of such petition call a special meeting of the Chapter, to be held on five (5) days notice in writing.

Section #10 – Order of Business

ARTICLE X – AMENDMENTS/MISCELLANEOUS

Section #1

Proposed amendments to these by-laws shall be presented in writing at a regular meeting of the Chapter and referred without debate to the Secretary of the Chapter for publication. Notice of such proposed amendments shall be mailed to the membership conjunction with a monthly bulletin at least five (5) days previous to the meeting at which same shall be considered and discussed. A two-thirds (2/3) vote of the members present and voting at said meeting shall be necessary for the adoption of such proposed amendments.

- These by-laws or any portion thereof may be temporarily suspended by a (3/4) three-fourths vote of the members present at any regular meeting except for specific contrary purposes in these by-laws contained.
- The Constitution and Laws of the Order and/or Roberts Rules of Order Revised shall govern in all cases not covered by the foregoing by-laws.
- These By-laws shall take effect when approved by the Supreme Advocate after approval by the members of the Chapter.
