First, our **Memorial Mass** will be **Sunday, November 8th**, at 11:00 AM at St. Agnes Cathedral. If you have a GPS, program in **28 Quealy Place, Rockville Centre**. Otherwise, here's how to get there:

Take the Southern State Parkway to Exit 19 South (Peninsula Blvd.) in Rockville Centre. Stay on Peninsula Blvd for approx. 1 **1/2** miles and make a left onto Lakeview Ave. Go straight and make a right at the second light onto North Village Ave. Stay on North Village and pass two lights and make a left onto Quealy Place. This is one block before the Rockville Centre train station. Parking is on the right.

Then at **8:00 p.m**. on **Friday the 13th**, our next Chapter meeting will be at the Catholic War Veterans Hall in Bethpage, hosted by **Rev. Michael J. Hartigan Council.** If you have GPS, program in **517 Central Avenue, Bethpage.** Otherwise, here's how to get there:

From the Southern State Parkway, take it to Exit 28 (Wantagh Avenue) Take Wantagh Avenue North to the end about 5 miles, where it joins Route 107/Broadway. Take Broadway North, and at that first light, go right. That's Central Park Avenue. The council is on the right about 1/4 mile down the road.

From the LIE (exit 41S) or Northern State (exit 35) go South on Route 107, past the Broadway Mall, Old Country Road, and Grumman's. After you pass Grumman's you'll see a bank on your left. Make that left onto Central Park Avenue. The council is on the right about 1/4 mile down the road. Their phone number's (516) 938-5033

Nassau Chapter bulletin context is underway!

Communicating the service and programs of your council's membership (and Columbiettes or Ladies Auxiliary and Squires) through a monthly or bi-monthly bulletin is a great way to keep your council abreast of its happenings and goes a long way towards membership retention and involvement. Last year we recognized 15 councils for the fine bulletins they submitted. This year we'd like to see double that many entries.

Here are the guidelines for this year's contest:

1) Newsletters must be written, edited, and published by council members.

2) Interested councils must submit a **minimum of three (3) issues** between **July 2009** and our Deadline of **May 8, 2010**. The more issues you publish and send us, the better chance you have of scoring well. All entries need to be in the committee's hands by the May 8th deadline.

3) Each issue must list the Council's name and number as well as the Editor's name. We also suggest you list the District number, since it is required for the State Bulletin Contest.

4) Send them in as printed, rather than via email. It's much easier to judge.

6) There will be plaques for First, Second, and Third Place. We'll also present certificates to every council that submits three or more issues.

7) As recommended by the committee, we'll grade newsletters on the following 100 point system:

Editing 15 points

Format 10 points

State News 10 points

Chapter/Conference news 10 points

Fourth Degree news 10 points

Insurance News 5 points

Supreme News 5 points

Fr. McGivney 5 points

Membership (this may include drives, member profiles, members name in local news, prayer requests, etc) 15 points Council News and Committee Reports 15 points
