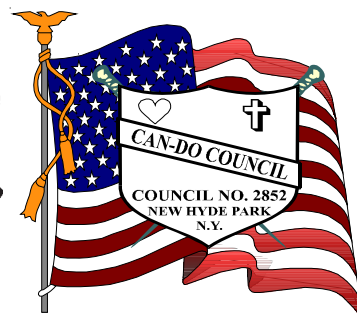

Supreme News

Approximately 2,000 children throughout Connecticut were treated to brand new coats free of charge the day after Thanksgiving. The Knights of Columbus distributed the new winter coats to children in need free of charge at six sites throughout Connecticut on "Black Friday," Nov. 29.

The Knights' Coats for Kids distributions ran from 10 a.m. to noon at sites in Bridgeport, Hartford, New Haven, Norwich, Stamford and Waterbury. As many as 500 coats were distributed at each location, with the total reaching 2,000 statewide.

The effort builds on a successful program held the day after Thanksgiving

last year in Bridgeport. And since 2009, the Knights of Columbus has given away 150,000 coats to children throughout the United States and Canada.

"As we begin the Christmas season, this program helps us to remember Christmas is a celebration of the gift of love God gave us in his son. Meeting the needs of children and families throughout the state in this way, allows us to share that Christmas spirit with our neighbors in a meaningful way," said Supreme Knight Carl Anderson. "With more than 2,000 coats distributed, today's program was an enormous success, and will make a real difference in the lives of these children."

Columbus Club Briefs

My Brother Knights:

And Sister Columbiettes - welcome back! It is my obligation to keep you up to date on our financial condition and the operation of our council building. I think it is time to prepare you for the worst possibility. On average it cost about \$11,000 a month to operate our building; taking into account property taxes, sales tax, permits, insurance, gas and electric. Keep in mind the Columbus Club pays for everything associated with the building and property. From the small expenses such as garbage pickup, cablevision,

exterminators, and the security system to the larger expenses like: building and equipment repairs, payroll expenses to just name a few. It is increasingly difficult to bring in the level of income needed to cover costs and have some profit left over for a rainy day. Our building has aged and we have not been able to make any major improvements. We need to clear at least \$11,000 from revenue generated from parties and hall rentals. Although there are good months we also encounter some very lean months; usually January to March and July and August. The parties are not what they used to be; they have gotten smaller and less frequent. Although the economy has improved there are still plenty of people watching what they spend and having large parties is not what they are spending their money on. And for the last several years our members have not utilized our council hall to the point of downsizing would not have any effect on the K of C mission and goals.

I think it is time to seriously discuss about downsizing to another location in New Hyde Park. We can talk about this at our January K of C business meeting. If one of our members has any idea how they can make it work, then come to the meeting and let us know about it.

I am sorry I had to bring this message at this time of the year but there is never a good time for this type of message. On behalf of the Columbus Club Board of Directors: Have a very Blessed Christmas and a Happy, Healthy New Year.

Food for Thought... Challenges in Feeding the World's Hungry

St. Paul, Minn (CNS) – With projections putting the planet's population at 9 billion by 2050, the question of how to feed them is taking on ever greater importance. But at the "Faith, Food & the Environment" symposium November 5-7 in St. Paul, held at the University of St. Thomas and sponsored by more than a dozen Catholic and agricultural organizations, some speakers suggest the question may need to be asked differently. "It's the wrong question," shared Fred Kirschenmann, a distinguished fellow at the Leopold Center of Iowa State University, giving people "a moral justification to continue doing more of what they've been doing."

Kirschenmann said enough food is being grown today to feed 10 billion people, yet 1 billion people remain chronically hungry. "It's a problem of poverty, it's a problem of entitlement, it's a problem of inequality," he said. It's also a problem of waste," Estimates put the amount of waste at 40 percent of all food grown.



Midnight Run Clothes Collection

Last year NHP Council began collecting men's clothes and accessories that were distributed by Molloy College Campus Ministries to the homeless on the streets of New York City through the Midnight Run organization. So far the response has been good, however they are still in need of donations: gently used men's clothing items: hats, shoes (sneakers preferably), backpacks, sweatshirts, T-shirts, long sleeve shirts, jeans, belts, and jackets (the larger the size, the better). Also new items such as socks, underwear and gloves. Anything donated will be distributed to those who most need it; donations will be accepted at the council.
